

Comment:

- One credit is 30 academic hours;
- The student's study days are five days a week, and the weekly load in the auditorium is 24 academic hours;
- The final control will be held at the end of the semester;
- Military training is included in the block of elective disciplines, and the military practice of students is organized during vacation period;
- When developing syllabuses of specialized disciplines, the requirements of Personnel customers are taken into account;
- Course project, the student is given 1 credit for coursework, allocating 30 academic hours from self-education hours;
- Internships are carried out based on the relevant disciplines or disciplines. The contact hour of qualification practice is equal to 30 academic hours per week;
- The number of alternative subjects per elective course should not exceed three, and training is carried out on the subject in which at least one academic group is formed based on the student's choice;
- Changes can be made to the disciplines of the competition, taking into account the requirements of Personnel customers;
- Practical classes and laboratory work in the subjects of the specialty, which will be included in the curriculum, will be carried out at higher educational institutions and base organizations and enterprises;
